Award-Winning Journalist to Speak at TCA's Fall Conference

Once again the Fall Conference is approaching, and your TCA officers have been working hard to plan and organize this annual meeting. One of the highlights of the event will be the Friday night dinner. We hope you will join us to welcome our speaker for this year's TCA dinner, Willy Stern.

Willy Stern, a former staff writer at *Forbes* and *Business Week*, has been with *The Nashville Scene* since 1996. His exhaustive investigations—into topics like airplane safety, police corruption, and crooked charities—have won numerous national journalism awards, including honors from the National Newspaper Association, ACLU of Tennessee, the Association of Alternative Newsweeklies, and the Association for Women in Communications. Stern also teaches part-time at Vanderbilt University, in the English and Communication Studies departments and at the Law School.

Stern's investigative and analytical work has been published in major publications around the globe including *The New York Times*, *The Wall Street Journal*, *The International Herald Tribune*, *The Chicago Tribune*, *The New Republic* and *National Review*.

Stern also teaches part-time at Colorado College in Colorado Springs, Colorado, and has taught as a visiting professor at Williams College in Williamstown, Massachusetts, and at Fisk University in Nashville, Tennessee. A popular speaker, Stern lectures frequently on topics ranging from journalism to humor, from ethics to international relations.

Before coming to Nashville, Stern lived and worked as a journalist in New York, Chicago, Tokyo, Johannesburg and New Zealand, including a stint as the Far East correspondent for the Tel Aviv daily *Ma'ariv*. He holds degrees from Williams College (B.A., 1983) and Harvard University (M.P.A., 1991).

Belmont Captures State Forensics Championship

Intercollegiate forensics is alive and well in Tennessee. Middle Tennessee State University hosted the 2005 Tennessee Intercollegiate Forensics Championship on Saturday, February 5.

Belmont University captured the overall sweepstakes championship.

In debate, Belmont cleared three teams into the semifinal bracket. In the final round, Belmont defeated Carson-Newman on split decision by the panel of judges. Walters State claimed the novice division championship, while MTSU placed second.

Tennessee State dominated the individual events competition with four champions and twenty-seven other finalists. Belmont placed second, and Carson-Newman placed third.

Competing schools were Belmont University, Carson-Newman College, King College, Lipscomb University, MTSU, Tennessee State, Tennessee Tech, UT-Knoxville, and Walters State.

With the end of this academic year, I'm hopeful that each of you had a productive, successful and satisfying year with your campus activities and personal endeavors. Per your wishes and suggestions, your Association officers, Interest Group Chairs and many, many individual members have taken the initiative to address each of our mutual interests.

Numerous recommendations have been made throughout the year by members. Electronic communication has been very productive as members were quite proactive by providing suggestions and directions for accomplishing objectives set last September.

As we had discussed and planned at the September Annual Meeting, an early spring semester submission date for programs and proposals (in order to have the program substantially complete by April) was accomplished. At the suggestion of many of our members, President-Elect McAvoy's February 21st date was substantially met and the program is now complete for the September Annual Meeting. You and your colleagues have a most interesting program planned that is centered on a theme of "Communication: Teaching, Learning and Applications". You will note that a Friday evening meal, with guest speaker, is planned for the Annual Meeting. A very reasonable \$65 per night room rate has been arranged with a deluxe continental breakfast provided for those registered at the headquarters motel. Thanks to the Publication Committee for the planning and initial writing of a TCA publication concerning "Tennessee Communicators." Paul Prill's panel will discuss progress to date on this important contribution at the Annual Meeting.

Our Association is actively pursuing planning to involve educators in the Tennessee Communication Association who teach units or courses in communication or who advise communication-related activities in

secondary schools in Tennessee. A special session is planned for the September Annual Conference to continue pursuing this goal. Robert Oliver (McCallie School) and Ralph Hillman (MTSU) are providing initial planning to Malcolm McAvoy.

The Tennessee and Kentucky Communication Association Executive Committees have agreed "in principle" to conduct a joint "sub-regional" conference at a location in Tennessee in September, 2008. The last joint conference was in Kentucky in 2001. The 2008 sub-regional conference will provide an opportunity to invite attendance and presenters from additional states. Malcolm McAvoy will be attending the KCA conference in September the week before our TCA Annual Meeting to gather suggestions and input regarding planning and logistics.

Membership development is progressing nicely, with special efforts at Middle Tennessee State University particularly noteworthy. Five students, at the urging of Janet McCormick, have joined the Association. We are hopeful that other institutions will follow the lead of MTSU.

At the urging of Past-President David Walker and the approval of your Executive Committee, recognition for Outstanding Student Presentation will be given in two categories, instead of overall Student Presentation. An undergraduate and a graduate will be recognized by the Association. It should also be noted that, once again, the Association will provide complimentary registration for students selected to present at the Annual Meeting.

Finally, Len Assante will Chair a panel to address current issues that affect the discipline in Tennessee. A number of issues affecting the Tennessee Board of Regents and University of Tennessee systems will be addressed.

I invite each of you to make plans now to attend our Annual Meeting on September 23-24 in Gallatin and to invite colleagues (full- and part-time) and students to attend the Meeting. See you in September!

Joint Tennessee/Kentucky Annual Meeting Planned

Although the 2001 joint meeting of the Tennessee and the Kentucky Communication Associations at Kentucky Dam Village State Park in Gilbertsville, KY, was smaller than anticipated because of the events of September 11, many considered the promise of future joint meetings worthy of exploration. Your TCA Executive Committee explored the viability of future joint meetings with Kentucky's Executive Committee during the fall months.

An agreement, "in principle," has been reached to host a joint conference/Annual Meeting in Tennessee in 2008. The location of the joint conference will be determined by the

Tennessee Communication Association. The initial meeting, with Michael Osborn, Len Assante and Dorothea Norton as "leads," was conducted with the understanding that meetings would rotate between Kentucky and Tennessee and further, that these joint sub-regional meetings would be arranged for mutually beneficial years.

Each Association will conduct a separate Business Session/Luncheon and separate Interest Groups/Panels/Programs. However, members may submit proposals for presentations and/or attend sessions of either Association. This was the case in 2001 at the Kentucky-hosted joint meeting.

For this second "sub-regional" meeting, efforts will be made to invite attendees from neighboring states. Discussions have included extending invitations to colleagues from northern Georgia, Alabama, Mississippi, and the Eastern regions of Arkansas and Missouri.

Malcolm McAvoy has agreed to attend the Kentucky Communication Association conference in September, the week before the Annual Meeting of the Tennessee Communication Association. The purpose of his attendance will be to gather KCA members' suggestions and to consider planning issues.

Corporate and Organizational Communication Interest Group

When it comes to Communication teaching, learning and applications, the overall theme of the 2005 TCA Fall Conference, the Organizational Communication Interest Group has a one track mind. In order to advance the effective use of communication skills in the Health Care Industry, we believe in assessing the status quo, identifying training needs, providing quality instruction in an interculturally diverse environment, and then

evaluating the success of our efforts and our "students".

Dr. Sharon Smith and Greg Simerly (Director of Debate) from MTSU will guide us through research that supports the significance of survey before initiating an employee training program thereby assessing employee communication needs.

Dr. Yang Soo Kim from MTSU discusses the need for Intercultural Training Programs in the healthcare setting. He indicates that while increasing business and profit, effective intercultural communication also affects patients' physical and mental well being.

Dr. Janet McCormick from MTSU offers practical training activities designed to meet Intercultural Training Needs in the healthcare setting addressing verbal and non-verbal communication variables in a diverse population.

Lori Kissenger, also from MTSU, presents unique research regarding a State-wide project called "Keymunicate" which demonstrates how the arts are a key to the communication process for people with disabilities.

Deborah Warner offers insight from her 26 years experience in Health Care Administration Processes regarding Communication Competencies in staff, office and clinical personnel.

The goal of this panel is to address the "hot topic" of communication training describing the needs of the healthcare industry, possible training activities and current/future trends in TN.

TBR Evaluates Lower-Division Classes

2005 continues to be an important year for the communication discipline in Tennessee.

The Tennessee Board of Regents has established a series of disciplinary task forces to examine the lower-division offerings within various disciplines state wide. These groups are tasked with developing a common lower-division offering in various majors. This would supplement the 41 hour common core curriculum in place across all TBR schools and would regulate the offerings at the community college level of the 19 hour area of emphasis. (The 41 hour GE core plus the 19 hour area of emphasis equal the 60 hour AA/AS degree or the freshman/sophomore portion of the BA/BS degree.)

The communication task force, after due consideration and input from many of our colleagues, has decided to table the issue for now, deeming the development of a common area of emphasis to be problematic and not necessarily in the best interest of the institutions or students.

engaging. The sessions will deal with best practices, assertiveness, and conflict management attempting win/win situations. The presenters are Kina Mallard, Union University; Len Assante, Volunteer State; and Teresa Collard, UT Martin.

Kina Mallard's session "Best Practices of Interpersonal Communication" will deal with an interpersonal communication topic. She will introduce her topic and engage the audience in an activity that will help them better understand the particular concept.

Len Assante in his session "Conducting an Assertiveness Inventory" will discuss how students have difficulty understanding and assessing their levels of assertiveness. He will explain the difference between assertive and aggressive behaviors and present a quick and easy activity which attempts to deal with the issue of assertiveness.

Teresa Collard's session, "Conflict Management: Striving for Win/Win" will present information on the various types of conflict management placing emphasis on win/win over win/lose. She will present an activity that will engage the audience in understanding how win/lose is often the paradigm for conflict management.

From the Executive Director's Desk by Dorothea O. Norton

How much is your Tennessee Communication Association membership worth to you? That depends; are you "just a member," or are you an involved member? If you perceive TCA to be an insignificant organization that really doesn't matter, what are you doing for TCA?

To each person receiving this Tennessee Communicator, TCA should be the premier organization you eagerly share with your colleagues and students as you urge them to become members. TCA should be the organization that excites you as you volunteer to serve on committees and in leadership roles. TCA should be the organization that involves you with the preparation of conference presentations as you make plans to attend the annual meetings.

TCA membership makes available many professional opportunities, including leadership and scholarship. A current "perk" included for all members is the National Communication Association publication *Communication Teacher*. (CT is \$32 for a 2005

individual subscription.) The annual Fall Conference is a TCA highlight. It provides opportunities for sharing scholarly endeavors and for gaining up-to-date ideas from both seasoned professionals and graduate school newcomers. Fall conference provides opportunities to network with communication scholars from around the state and to form long-lasting, professional friendships. There are opportunities to laugh, to savor good food, to relax, and to escape the pressures of work, whether the conference is held on a college campus, at a hotel, or in a state park.

Working together, TCA members can and do make a difference in communication education in Tennessee, as evidenced by the recent influence upon the TBR schools' public speaking requirement. Working together, TCA members can make TCA an outstanding organization worth much to involved Tennessee communication teachers/professors.

TCA Membership Information

The Tennessee Communication Association is a professional organization for communication scholars—including, but not limited to, faculty and students—who seek to improve communication education at all levels in Tennessee, encourage research in communication, and foster community recognition of effective communication.

Student membership in TCA is \$5 a year, whether undergraduate or graduate. Membership in a professional association is a plus; an opportunity to interact with faculty and students of communication across the state, to establish professional networks, and to broaden discipline perspective. State membership is affordable compared to regional and national membership.

Part-time and/or adjunct faculty dues are also affordable, at \$10 a year. The opportunity to interact with other communication faculty and professionals is an "energizer." A subscription to the *Communication Teacher*, includ-

- **John Campbell** was awarded the 2005 James Madison Prize for Outstanding Research in First Amendment Studies from the Southern States Communication Association during their annual conference.
